

1. The Amateur Bowlers Tour (ABT) is a private membership organization open to members only. ABT Membership has restrictions and limits. If you are not sure of your eligibility, please complete your Membership application and have it submitted by 8/1/11 to confirm your eligibility for this and future ABT events.

2. **On Site Registration fee \$50.00.**
Standard National Membership \$50.00.
Gold Membership \$200.00.

Unlimited Entries. Each bowler please prepay a minimum of 1 (one) entry in advance. Failure to pre-pay for at least one squad will result in the member being charged the On Site Registration fee of \$50.00. To guarantee bowling additional squads, the entries must be paid before the deadline date for tournament entries. If additional squads are paid at the tournament site, reservations are on a first come, first serve basis. If your requested squad has sold out, you will be moved to an earlier squad. **NO RESERVED ENTRIES ACCEPTED WITHOUT FULL PAYMENT!**

3. Entry fee: **\$275.00** per squad for non Gold Members, not staying in the ABT room Block at South Point, pre-paying by 8/1/11, and meeting the national local entry requirement of ten (10) squads between 4/6/11 and 9/10/11, and bowling in each of the prior 2011 national events. There is a twenty five dollar (**\$25.00**) discount for each of the above six (6) items, thus your entry fee can be as low as **\$125.00** per squad. If your hotel room is paid for by the casino, you still need to pay and reserve through the ABT room block, if you want the \$25.00 entry fee discount. The Bonus Progressive entry fee guarantees the place money for all semi-finalists in this tournament. **Your prize money will be ½ of the guarantee if you don't pay the Bonus Progressive entry fee.** The prize fund will be returned 100%.

NO PERSONAL CHECKS ACCEPTED AFTER SEPTEMBER 20, 2011.

4. Refunds on all unused entries are available at tournament site about one (1) hour after the squad has floored. Unused entries not refunded at site will be mailed to your address on this application about fourteen (14) days after completion of the tournament. ALL Credit card refunds are subject to **\$10.00** service charge per squad.

5. **PLEASE BE ON TIME FOR YOUR SQUADS.**

6. All members are required to check in 30 minutes prior to your scheduled squad time. If you plan on bowling consecutive squads, please have someone onsite available to check you in. ABT Staff cannot be responsible for checking you in.

7. Should a member fail to show at their assigned time, that spot will go to the first bowler standing by.

There will be no buying, selling or giving away spots on any tournament squad. **NO EXCEPTIONS!**

8. Lanes will be assigned by the tournament staff. Members wishing to bowl together must check in together. No member will be allowed to change lanes unless directed to do so by a Tournament Director. Any member refusing to accept an assigned lane will forfeit entry fee and will not be granted additional entries in this tournament.

9. Prize checks will be available after the conclusion of the final (championship) match.

10. One (1) in every eight (8) entries is guaranteed to cash. See the Tour Type explanation letter for maximum cuts per squad block. Director's decision will be final. Re-entry scores for the main event will be disqualified for any member that has already made the Semi-Finals CUT in any prior squad block.

11. All Amateur Bowlers Tour (ABT) rules, regulations and policies will apply in this event (including re-rating rules). Amateur Bowlers Tour (ABT) dress and conduct rules will be strictly enforced. Tournament Director's decision on any issue not covered by ABT rules is final.

12. Members who have established right and left handed Amateur Bowlers Tour (ABT) averages must declare which hand will be used at the time of entry application. Should a member be bowled out in any (ABT) branch with either hand, they will not be eligible with that hand, unless they have established a national average with that hand.

13. Bowlers entering all ABT local and national tournaments will be subject to average, handicap & bonus pin adjustment by the host tournament director and / or tournament committee based on past performance or current ability. This includes on site re-rate. Any member not accepting an on site re-rate will have their membership suspended and will be disqualified from all current national events.

14. All Branch Members, please keep copies of your local branch entry forms to help get your entry fee discounts. This can be confirmed by logging into your account in the ABT national Database. This information is only available online so contact ABT headquarters for details at mail@abtbowling.com.

15. There will be a \$50.00 handling charge per check or credit card on all returned checks or credit cards. Member will be on a cash basis for all future tournaments in the Amateur Bowlers Tour (ABT) **NO EXCEPTIONS!**

16. Each member must have a current ABT and USBC membership card. Your ABT Membership Card **MUST** be presented at Check In. USBC card **Must** be presented at Semi-Finals Check In. **ABT REPLACEMENT CARD FEE IS \$30.00.**

17. No bowler is to receive a prize check without verification of USBC membership. Bowlers may purchase unattached membership card prior to bowling (\$25.00).

18. Upon submitting this entry form, member agrees to abide by All ABT rules on this entry form, and as they may be amended by ABT National Headquarters. We cannot accept responsibility for entries paid to local Branches. **REMEMBER**, each Branch is busy operating weekly tournaments and may simply forget or delay forwarding your entry without intending any harm. Eliminate this problem by sending your entry direct!

The National Office and Host Branch cannot be held responsible for any non-delivery of the U.S. Mail. Should you not receive a confirmation from us within fourteen (14) days call 801-840-0438 during normal business hours.
